1. Introduction

Welcome to Local Kickabout, operated by The Green Motive LTD (“we”, “us”, or “our”). These Terms and Conditions (“Terms”) apply to all individuals (“you”, “your”, or “Participant”) who book, attend, or take part in any Local Kickabout football sessions (the “Sessions”).

By booking or participating in a Session, you confirm that you have read, understood, and agree to be bound by these Terms. If you do not agree with any part of these Terms, you must not take part in the Sessions. These are designed to ensure a safe, fair, and enjoyable environment for all participants.

2. Eligibility

Participants must be:

- Aged 18 or over.
 - Physically fit to participate in moderate to vigorous physical activity.
 - Not under the influence of alcohol or drugs during any session.

3. Free Taster Session and Membership

- Each new participant is entitled to one free taster session.
- After the taster session, continued participation requires signing up for a monthly membership via direct debit of £30.
- The monthly fee covers access to up to 4 weekly sessions per month, effectively costing £7.50 per session if all sessions are attended. Please note, the number of sessions may vary depending on bank holidays or venue cancellations.

- The direct debit will be taken automatically each month unless cancelled in accordance with our cancellation policy (see Section 4).

4. Cancellations and Refunds

- If you are unable to attend a session, no refund or credit is given for missed sessions under the membership model.
 - You may cancel your membership at any time by providing at least 7 days' notice before your next billing date.
 - We reserve the right to cancel or reschedule sessions due to weather, venue issues, or other unforeseen circumstances. Changes to session time, date, or location do not entitle members to a refund, credit, or partial refund.

5. Conduct and Safety

- All participants must treat others with respect and play in a fair and sportsmanlike manner.
 - Dangerous, aggressive, or abusive behaviour will result in immediate removal and possible permanent ban.
 - Shin pads are optional, however suitable footwear is required for your safety.
 - You must inform us of any relevant medical conditions or injuries prior to participation.

6. Liability and Insurance

- Participation is at your own risk. Local Kickabout is not liable for any injuries, loss, or damage sustained during or as a result of participation, except in cases of proven negligence.

- We may take photos or videos during sessions for promotional purposes. By participating, you consent to this use. Please inform us in advance if you do not wish to be photographed or filmed.

8. Privacy

- Your personal data will be handled in accordance with the UK GDPR and our Privacy Policy. We do not share your information with third parties except where required by law or for operational purposes (e.g. insurance, payment processing).

We reserve the right to update these Terms and Conditions at any time. Continued participation constitutes acceptance of any changes.

10. Governing Law

These Terms and Conditions are governed by the laws of England and Wales. Any disputes shall be subject to the exclusive jurisdiction of the English courts.
